

PAWCon 2025 PARENTAL CONSENT FOR MINOR ATTENDEES

Welcome to PAWCon 2025! PAWCon is a convention for people who love anthropomorphic animal characters and costuming. It is taking place at the Doubletree Hotel at 2050 Gateway Dr in San José, CA from 6 November through 10 November 2025, and is brought to you by PAWCon Inc. Admission to the convention is open to all: the convention does not screen or evaluate attendees prior to admission. Neither the convention, PAWCon Inc., nor the Doubletree Hotel bears any responsibility for the actions or conduct of individual convention attendees. Every attendee attends the convention at their own risk.

Parental consent is required for any attendee who is under the age of 18 on 6 November 2025. This consent may be provided in person by a parent or legal guardian at convention registration using this form, or this form may be notarized beforehand, and presented at convention registration by a minor who is at least 16 years of age on 6 November 2025. Minors under the age of 16 on 6 November 2025 must be escorted at all times by a parent or legal guardian who is also a registered attendee of the convention. The convention cannot accept any other form of parental consent.
